20/1 Minutes of meeting no.19

20/4 Hearing of Reference NV55

The Committee formally heard joint reference NV55 from English Welsh & Scottish Railway and Network Rail. The determination NV55 of the Committee is attached.

20/5 Update on references

The Secretary reported that the position on outstanding references received was as follows:

- nv33 Although the Rail Regulator announced his decision in March 2003 in respect of an appeal referred by Network Rail, written notice of his reasons has not yet been published. In the meantime the parties have reached terms of settlement and, in January 2004, the appeal was withdrawn. The Regulator has made no further comment nor given any detailed reason for his decision previously announced. The Chairman advised that he would seek to ascertain the position.
- nv45 As a consequence of the terms of settlement negotiated by GNER and Network Rail, and the withdrawal of Network Rail's appeal against determination nv33, GNER has now advised that it has withdrawn its reference nv45;
- nv54 A joint submission is awaited from ScotRail Railways and Network Rail on the subject of disputed revenue losses occasioned by Network Changes;
- nv57 Network Rail has notified its intention to refer an issue relating to a proposed Network Change at Stowmarket goods loop; if unresolved a hearing will be scheduled in March or April;
- nv58 Network Rail has notified its intention to refer an issue relating to a proposed Network Change at Ruscombe up goods loop; if unresolved a hearing will be scheduled in March or April.
