## 41/1 Minutes of meeting no.40

# 41/2 Record of Hearing of reference no.155

### 41/3 Record of Hearing of reference no.161

The Committee noted that the parties concerned had, since the hearing, fully complied with paragraph 13.2 of Determination 155 and supplied the necessary documentation.

# 41/6 Matters arising from Determination 161C

The Committee noted firstly that Railtrack had, since the hearing, complied with paragraphs 9.1 and 9.2 of Determination 161C and supplied the necessary documentation; and secondly that Arriva Trains Northern had made no comment.

## 41/7 Hearing of Reference no.168

The Committee formally heard joint reference no.168 from the Grand Central Railway Company and Railtrack. The determination 168 of the Committee is attached.

#### 41/8 Other references submitted to the Committee

The Secretary advised Members that the current position on other references submitted to the Committee was as follows:

Rules of the Route/Plan in respect of 2003/04

- from Great North Eastern Railway (GNER) concerning the Rules of the Plan had been deferred until December 2002; following further discussions with Railtrack the matter was resolved and the reference was withdrawn by GNER;
- ttc153 ScotRail Railways has concluded productive discussions with Railtrack and subsequently withdrawn this reference concerning the Rules of the Route/Plan;
- West Coast Trains has concluded productive discussions with Railtrack and subsequently withdrawn this reference concerning the Rules of the Route;
- North Western Trains has concluded useful discussions with Railtrack and subsequently withdrawn this reference concerning the Rules of the Route/Plan;
- silverlink Train Services has concluded further discussions with Railtrack and subsequently withdrawn this reference concerning the Rules of the Route;
- ttc158 Central Trains, having concluded further discussions with Railtrack, withdrew this reference concerning the Rules of the Route/Plan;
- from GNER concerning the Rules of the Route had been deferred until December 2002, and, although resubmitted by incorporation within reference ttc169, the elements which had originated as ttc159 were now resolved, and had been withdrawn by GNER from reference ttc169;
- ttc160 West Anglia Great Northern (WAGN) has concluded discussions with Railtrack and withdrawn this reference concerning the Rules of the Route/Plan;
- ttc161D Arriva Trains Northern (ATN) and Railtrack were given more time by the Committee, as directed in Determination 161A, to hold further discussions on aspects of the Rules of the Route relating to section 7 items for Summer 2003; the parties had subsequently reached a successful conclusion and ATN confirmed that it no longer wished to proceed with a hearing on this aspect [see also minute 40/6];

- ttc161E ATN and Railtrack were given more time by the Committee, as directed in Determination 161A, to hold further discussions on aspects of the Rules of the Route relating to section 7 items for Winter 2003; the parties have accordingly held further discussions, but have not yet reached any settlement; a hearing on any outstanding issues will take place on Friday 31 January 2003;
- ttc162 English Welsh & Scottish Railway (EWS) is still continuing discussions with Railtrack concerning the Rules of the Route/Plan; a hearing of any unresolved issues will take place in early February 2003

ttc164 EWS has, following discussions with Railtrack, withdrawn this reference;

Version 3 of the Rules of the Route/Plan in respect of 2003/04

- ttc165 EWS registered a reference about Railtrack's possession strategy at Dolphingstone, but the matter was resolved through discussions with Railtrack and EWS thereafter withdrew the reference;
- ttc166 Freightliner registered this reference, but withdrew it following productive discussions with Railtrack;
- ttc167 CrossCountry Trains registered this reference, but withdrew it following productive discussions with Railtrack;
- ttc169 GNER has been holding further discussions with Railtrack; a hearing of any unresolved issues will take place in early February 2003;
- ATN has been holding further discussions with Railtrack; a hearing of any unresolved issues will take place in early February 2003;
- ttc171 Thames Trains registered this reference, but withdrew it following productive discussions with Railtrack;

- ttc172 Freightliner has been holding further discussions with Railtrack; a hearing of any unresolved issues will take place in early February 2003;
- ttc173 Great Western Trains registered this reference, but withdrew it following productive discussions with Railtrack;
- ttc174 EWS registered this reference, relating to its Royal Mail services, but withdrew it following productive discussions with Railtrack; Members noted without comment the joint position paper produced by the parties recording the basis of their agreed solution
