40/6 Request from the Parties to Reference 161

Arriva Trains Northern and Railtrack jointly requested, in respect of Determination 161A clause 3.2, that they be permitted more time to try to reach a resolution of their dispute before preparing a submission on outstanding items. In particular they requested that the date for submission of outstanding Rules of the Route section 7 items for summer 2003 should be deferred from 1st November by two weeks. The Committee, noting that this would not prejudice the target date for a hearing on 29th November, encouraged the parties in their endeavours to resolve the outstanding issue, but stipulated that any joint submission should be lodged with the Committee Secretary by 15 November 2002.
