# 50/1 Minutes of meeting no.49

ttc197 from EWS: following further discussion the issues have now been resolved and EWS is about to withdraw the reference;

ttc198 from CrossCountry Trains: Network Rail has rearranged the possessions that led to the dispute and CrossCountry Trains has now withdrawn the reference;

Amendments to the Rules of the Route/Plan in respect of 2003/04 – Periods 4b & 5

ttc204 from CrossCountry Trains: withdrawn following discussions between the parties;

### Summer 2004 Timetable Offer

ttc200 from Freightliner: withdrawn following resolution of all outstanding issues with Network Rail;

ttc201 from EWS: further discussions are taking place between EWS and Network Rail in an effort to resolve the issues; any unresolved elements will be the subject of a hearing in late February 2004;

ttc202 from Freightliner Heavy Haul: hearing to take place in February 2004;

## Spot Bid

ttc205 from EWS: contending that, in the absence of a timely response from Network Rail, a Spot Bid for 7O81 should be deemed to be accepted; if unresolved a hearing to take place in February 2004;

Robin Davis raised an issue regarding interpretation of the priorities set out in Condition D3.4, but the Chairman advised that that it was an inappropriate matter for discussion, and accordingly the matter was withdrawn
