Directions relating to Timetabling Panel hearings of disputes TTP493, TTP494, TTP495 and TTP518

Having read your submission documents for the Panel hearing on 18 September 2012, there are certain items of additional information which I consider are necessary to assist the Panel in its consideration of the issues. Accordingly, I have decided to give the following directions:-

1. *In relation to all four dispute references*

By 16 00 on Wednesday 12 September 2012, Grand Central shall supply to the Committee Secretary (copy to Matt Allen & Daniel Grover at Network Rail): (a) a short statement setting out the legal relationship between Grand Central Railway Company Limited and Alliance Rail Holdings Limited, and (b) confirming specifically which of Grand Central Railway Company Limited and Alliance Rail Holdings Limited were variously party to, or the author of, each of the several agreements, entitlements, proposals and other communications referred to in the sole submission document.

2. *In relation to disputes TTP493, TTP494 and TTP495*

By 16 00 on Wednesday 12 September 2012, Grand Central shall supply to the Committee Secretary (copy to Matt Allen & Daniel Grover at Network Rail) a simple chronology of all relevant exchanges (e.g. letters, e-mails, meetings, decision notices) and relate the entries to the process timeline as set down in the version of Part D of the Network Code which applied at the time. Upon receipt, Network Rail is to examine the document and, by 12 00 on Friday 14 September 2012, provide the Committee Secretary with written confirmation - or contrary observations - regarding its accuracy (copy to Chris Brandon for Grand Central).

3. *In relation to disputes TTP493, TTP494 and TTP495*

By 16 00 on Wednesday 12 September 2012, Grand Central shall supply to the Committee Secretary (copy to Matt Allen & Daniel Grover at Network Rail) copies of the items of correspondence to which reference is made in the letters contained within Annexes D and E of its sole submission document.

The Committee Secretary is to provide all Panel members with a copy of this letter and the supplementary information received in response to it, also to place the documents on the Committee's website.
